

## PARENTAL WAIVER AND RELEASE OF LIABILITY

**IMPORTANT NOTICE:** This document affects your legal rights. Read carefully before signing.

I, \_\_\_\_\_ (parent/guardian), acknowledge that I am the parent or legal guardian of \_\_\_\_\_ (minor's name) and have the legal authority to sign this agreement on their behalf.

I understand that golf is an inherently dangerous recreational activity that involves significant risks of serious injury or death that cannot be eliminated regardless of the care taken, including but not limited to being struck by golf balls, clubs, or equipment; injuries from golf carts, maintenance vehicles, or other motorized equipment; falls, slips, and injuries from uneven terrain, water hazards, and course obstacles; weather-related hazards including lightning, severe storms, and extreme temperatures; injuries from wildlife, insects, or plant life; exposure to chemicals, fertilizers, or pesticides used in course maintenance; and injuries resulting from the actions of other golfers or course users.

I voluntarily assume all risks associated with my minor child's participation in golf activities at the Links at Boynton Beach, whether those risks are known or unknown, obvious or not obvious, and whether they result from the negligence of others, natural causes, or any other cause. To the fullest extent permitted by Florida law, I hereby release, discharge, and covenant not to sue the City of Boynton Beach, its officials, employees, agents, contractors, and volunteers from any and all liability, claims, demands, losses, or damages arising out of or related to my minor child's participation in golf activities, including but not limited to personal injury, disability, death, property damage or loss, economic losses, and emotional distress or mental anguish. This release applies to claims arising from the negligence of the Released Parties, except for gross negligence or intentional misconduct as defined by Florida law.

I agree to indemnify and hold harmless the City of Boynton Beach from any claims, lawsuits, damages, or expenses (including attorney fees) arising from my minor child's participation in golf activities, including claims by third parties. I authorize the City of Boynton Beach to secure emergency medical treatment for my minor child if needed and understand that I am responsible for all medical expenses incurred. I agree that my minor child will comply with all facility rules, policies, and safety instructions and understand that violation of the rules may result in immediate removal from the premises.

This agreement is governed by Florida law. I acknowledge that section 768.28, Florida Statutes, may limit claims against the City of Boynton Beach, that this waiver is intended to be as broad and inclusive as permitted by Florida law, and that if any portion of this agreement is deemed invalid, the remaining provisions shall remain in full force. I acknowledge that I have read this entire document and understand its contents, that I am signing voluntarily with full knowledge of its significance, that I have had the opportunity to consult with an attorney, that no oral representations have been made to induce me to sign, and that this agreement is binding upon my heirs, executors, administrators, and assigns.
