




Reasons for Operating in Boynton Beach*


Ratings

- 3 in 4 business owners and managers rated the City's level of commitment to retaining its existing businesses and industries as "excellent", "very good", or "good"




Top Business Difficulties*





Satisfaction with City Services





City Codes and Regulations¹




Parking

Customer Parking




Employee Parking




Resolving Issues






Job Creation


- 1 in 3 business owners and managers plan to expand their business within the next year


Meetings and Events

- Over half of business owners and managers would attend business networking group events




Return on Taxes

- 3 in 4 business owners and managers rated the services they receive in return for their tax dollars as “excellent”, “very good”, or “good”




Use of Financial Incentives

- If the City of Boynton Beach offered financial incentives to businesses, nearly a quarter of all managers and owners would use these incentives to hire more employees




Business Owners and Managers

 - 4% of lessees are interested in purchasing the property






Employees




